#### **Terms of Service**

Welcome to Kamelle Grocery (the "Company," "we," "us," or "our"), a grocery service owned by Broadstone. These Terms of Service ("Terms") govern your access to and use of our website, mobile apps, and services (collectively, the "Service"). By accessing or using the Service, you agree to these Terms. If you do not agree, you may not use or access the Service.

#### 1. Definitions

- User / You / Your: any individual or entity accessing or using the Service.
- **Account**: your registered user account on the Service.
- Order: a purchase transaction made via the Service.
- **Products**: goods sold via the Service (groceries, food items, etc.).
- **Third-party**: any party other than you or the Company.

## 2. Eligibility & Account Registration

- 1. You must be at least 13 years old (or the age of majority in your jurisdiction) to use the Service.
- 2. To make purchases, you must register an Account, providing accurate, current, and complete information.
- 3. You are responsible for maintaining the confidentiality of your account login credentials and for all activity under your account.

than courts), unless prohibited by law.

 In the event arbitration is unavailable, you and we each consent to exclusive jurisdiction of state or federal courts located in [State / County].
